



# OUYEN P-12 COLLEGE

## UNIFORM POLICY

### PURPOSE

The purpose of the Student Dress Code is to outline Ouyen P12 College's requirements for student dress and appearance and to provide information about uniform purchase and support, dress code implementation and exemption processes.

This dress code has been developed by Ouyen P12 College's School Council in close consultation with our school community to ensure that it respects the rights of individual students whilst reflecting the values and interests of our community.

The Student Dress Code aims to:

- foster a sense of community and belonging and encourages students to develop pride in their appearance
- support Ouyen P12 College's commitment to ensuring that our students feel equal and are dressed safely and appropriately for school activities.
- reduce student competition on the basis of clothing
- enhance the profile and identity of the school and its students within the wider community.

The School Council has developed a dress code that we believe provides a range of choices for students and is cost effective for families.

### SCOPE

Students are expected to comply with this Student Dress Code while traveling to and from school, during school hours and when attending school activities.

### UNIFORM AND APPEARANCE

**The full list of Ouyen P12 College's compulsory school uniform items are available at Appendix A to this policy.**

#### **General appearance**

While at school, travelling to or from school or participating in school activities, Ouyen P12 College students must comply with the following:

- Uniforms must be clean and in good repair
- Uniforms must be clearly marked with the owner's name
- Additional layers of clothing may be worn underneath the uniform for added warmth, provided these undergarments are completely hidden.

#### **Jewellery and cosmetics**

Occupational Health and Safety Regulations are important at our college. For this reason and to ensure consistency the following rules apply to all students wearing jewellery whilst in school uniform.

**Students may wear:**

- Watch
- One plain sleeper or one small stud in each ear

- One flat ring may be worn by students in years 9 to 12
- No rings to be worn by P-8 students
- Clear nail polish only
- Ribbons in school colours

Facial and body piercings are not permitted and must be removed or covered whilst in school uniform.

- **Cosmetics may not be worn at school. Only clear nail polish is permitted.**

### **Hair and Sun safety**

Shoulder length or longer hair is to be tied back to help restrict the spread of nits and lice and for student safety.

School uniform hats must be worn outside from September 1<sup>st</sup> to 30<sup>th</sup> April and on any other day prescribed by the school. School uniform hats may also be worn outside of this time period, by parent or student choice.

### **Hats are not to be worn inside.**

Students are permitted to wear sunglasses during outdoor activities. Sunglasses should be close-fitting, wrap-around that meet the Australian Standards 1067 and cover as much of the eye area as possible. (Student needs to have evidence the Glasses are to Standard)

### **PURCHASE OF UNIFORMS**

Uniform items can be purchased from Totally Work Wear & Dobsons and some Mildura stores.

School Supply;

The school will take orders twice a year for Rugby tops, Dresses and Skirts for families to order.

A minimum of 25/50 will be needed for the school to process the order. (as per supplier request)

The school will advertise in Term 1 and term 3 for orders of Rugby tops, Dresses and Skirts.

OuyenP12 College operates a limited second-hand uniform store for parents. (Requests can be directed to the office).

### **Support for families experiencing difficulty**

Please contact the Principal to discuss support that we may be able to provide to families experiencing difficulty meeting uniform costs, including information about eligibility for uniform support through State Schools' Relief. Ouyen P12 College has some uniform items available to families to borrow on request.

### **IMPLEMENTATION**

Ouyen P12 College will ensure that this Student Dress Code is communicated to all families and students through our Website, Newsletter and Year Level Meetings. We will assist students who may be experiencing difficulties complying with this policy where possible.

The new uniform policy will have a transition for all of 2020. (Children can still wear both old and new uniform in 2020). In 2021 the policy is in full implementation

Students wearing non-compliant uniform items may be asked to change into a compliant item of clothing provided by the school.

If a student is out of school uniform or otherwise breaches the Student Dress Code on a recurring basis, a note will be provided to the student and parents by the Year Level Coordinator. If non-compliance with the dress code becomes a continued occurrence, the Principal will be informed and a phone call home may be required by the year level coordinator. In this event, the school will continue to work with the student and family to support compliance.

Measures taken by Ouyen P12 College to address concerns about student non-compliance with the Student Dress Code will also be addressed in accordance with our Student Wellbeing and Engagement Policy.

### EXEMPTIONS TO STUDENT DRESS CODE

We recognise that there may be situations where the application of this dress code may affect students unequally.

Students and their parents or carers may apply in writing to the Principal for an exemption to this Student Dress Code if:

- an aspect of this code prevents the student from complying with a requirement of their religious, ethnic or cultural beliefs or background
- the student has a particular disability or health condition that requires a departure from the dress code
- the student or their parents/carers can demonstrate particular economic hardship that prevents them from complying with the dress code.

When the Principal receives a request for an exemption, they will:

- consider the grounds for the exemption request
- explain the process to the student and/or their parents/carers
- encourage the student and/or their parents/carers to support their application with evidence.

The Principal or delegate will then try to negotiate a resolution that is acceptable to all parties. If an exemption is not allowed, then written reasons will be provided to the student and/or their parents or carers.

### CONCERNS ABOUT THIS STUDENT DRESS CODE

## APPENDIX A: Ouyen P12 College UNIFORM ITEMS

### Uniform 2020

#### Jumper

##### P-12-Jumper

- Burgundy Knitted jumper

##### Polar fleece

- Burgundy polar fleece jumper with zip F-4

##### YR 11&12 jumper

- Have a choice to purchase a new Blue Knitted Jumper. They can embroider VCE, year and Name. They can also choose to embroider VCE, year and Name on Current Burgundy Knitted Jumper.

##### Yr. 12 Top

– designed and sourced by students in Year 12, agreed to by VCE Coordinator, It must predominantly be school uniform colours. Day of use to be determined by VCE coordinator and students. (only to be worn one day a week)

#### Polo shirts

-Burgundy/White polo -short and long sleeve

##### Gr 6 t-shirt

– burgundy/white polo, students' names/design, can be worn 5 days/week

#### Skorts

F-4 Plain navy skorts without decoration or brand name

#### Socks or tights/stockings

Black or White (no logos)

Navy blue tights/stockings

#### Footwear

Appropriate footwear is to be worn. Summer sandals with covered toes, black leather shoes. No thongs or open-toed sandals are permitted.

Must have leather upper (non-porous- for all Technology, Science, Ag subjects).

#### School Coat

Navy Blue coat and school logo

May be worn in class with the exception of Technology & Science classes.

#### Headwear

School colour hair ribbons, “scrunchies” or headwear worn as part of cultural/religious beliefs.

#### Dresses

F-12-School Dress- As supplied by Dobsons ordered through school office

#### Tartan Skirt – current

Navy blue tights with tartan skirt- As supplied by Dobsons ordered through school office

#### Trousers

-Navy blue School Pants/trousers F-12

- Navy blue Track pants F-4

**Hat**

- Plain Navy blue bucket hat (no advertising logos) or with school logo.

**Shorts**

**Shorts** – navy blue, mid-thigh, dress shorts without decoration or brand name (can be covered by school emblem sew on badge).

**Sports Uniform – to be worn during Sport and on Sporting Events****Shirt**

– Olympic or Insignia House shirt, school Sport Shirt

**Shorts**

– Navy Blue or Black Sport Shorts

-Navy Blue Track pants

-Plain Black sports tights

**Socks**

– Black or white with NO logo

**Rugby top**

– Navy Blue with 2 white stripes either side of sky blue stripe.

**There are specific uniform requirements for students participating in specialist sports when representing the school. These uniforms are provided by the school for the duration of the sports season.**
